Buel was born Aug. 3, 1939, in Cleveland, Okla., to Francis and Madie (Smith) Duncan. Reared and educated in Arkansas City, he graduated from Arkansas City High School in 1957. He later attended Arkansas City Junior College (Cowley College) and New Mexico State University. He also served in the United States Army.

Buel married Sybil Louise Allen in 1960. She preceded him in death in 1992.

He married Susan (Powers) Hunt in 1998.

Buel was a longtime contractor/carpenter in the Cowley County area. He worked for Snodgrass/Funk Construction and Lord Construction and was co-owner of Duncan-Hensley Construction which later became Duncan Construction. Buel built many homes and businesses in the Arkansas City area and was the youngest foreman on the Arkansas City Junior High construction team in the late 1960s.

Buel was also a hog farmer and was very active with the high school FFA and local 4-H.

He was a member of the Shelton-Beaty Post 18 American Legion and the Arkansas City Lions Club.

In addition to his parents, Buel was preceded in death by his first wife Sybil; sister Marilyn Newman; and infant daughter Susan.

Survivors include his wife Susan Duncan, of the home; children Becky Hill and husband Bronze, John Duncan, and Ryan Hunt and wife Deja, all of Arkansas City, Regan Hunt, Wichita, and Stacey Hunt, Haysville; brothers Richard Duncan and wife Lora, and Tommy Duncan, all of Arkansas City; six grandchildren and four great-grandchildren.
